REGULATIONS made by the Minister responsible for International Financial Services, after consultation with the Registrar, in exercise of the powers conferred upon him by section 28 of the Protected Cell Companies Act, Chapter 271 of the Laws of Belize, Revised Edition 2000 (as amended by Act No. 25 of 2000), and all other powers thereunto him enabling.

Short title.

1. These Regulations may be cited as the

PROTECTED CELL COMPANIES (REGISTRATION) REGULATIONS, 2008.

Interpretation. 2. (1) In these Regulations –

CAP. 271 Act No. 25 of 2000 "the Act" means the Protected Cell Companies Act;

(2) Other words and expressions used herein shall have the meanings respectively assigned to them in the Act.

incorporation of a protected cell company or for the conversion of an existing company into a protected cell company, as required by section 9 of the Act, shall be made in the form of the First Schedule and shall be accompanied by such fee as is prescribed in the Sixth Schedule.

4. The consent of the Minister required under section 9 of the Act shall be in form of the Second Schedule.

Application to the Registrar for incorporation of a protected cell company.

- 5. An application to the Registrar for the incorporation of a protected cell company or for the conversion of an existing company into a protected cell company shall consist of the following documents:-
 - (a) a copy of the Minister's consent granted under section 9(1) of the Act;

- (b) 2 copies of the Memorandum and Articles of Association of the company;
- (c) 5-year business plan;
- (d) details of cell accounts to be administered (if known);
- (e) a statement that the company's shares will be in registered form and that the company will not issue any bearer shares;

- (f) such fee as is prescribed in the Sixth Schedule; and
- (g) any other documentation as may be required by the Registrar.

6. The certificate of incorporation of a protected cell company shall be in the form set out in the Third Schedule.

Creation of protected cells.

7. An application to the Registrar to create protected cells and to operate protected cell accounts shall be in the form set out in the Fourth Schedule.

8. An application to the Registrar for approval to appoint a protected cell account representative in Belize shall be in the form set out in the Fifth Schedule.

9. The fees for various activities and services under the Act and the Regulations shall be as set out in the Sixth Schedule.

Commencement.

10. These Regulations shall come into force on signature.

NOTES:

- (1) The annual fee must be paid on or before every 31st of December during the currency of the registration of the protected cell company or approval of the protected cell account.
- (2) If the annual fee is not paid on or before every 31st December but is paid on or before the 31st March of the following year, a late payment penalty of 25% of the annual fee will be additionally payable.
- (3) If the annual fee is not paid on or before every 31st March but is paid on or before the 30th June in the same year, a late payment penalty of 50% of the annual fee will be additionally payable.
- (4) If the annual fee is not paid on or before every 30th June in the same year, the protected cell company will be in breach of the Act and the Regulations, and the Registrar shall remove the company from the Register. If the annual fee for an individual cell account is not paid by the said date, the Registrar will require the protected cell company to remove the protected cell account from within the terms of its governing instrument.

- (5) The Registrar may in his discretion restore a protected cell company to the Register or restore an individual cell account on such conditions as he may specify, provided that the application for restoration is made within three (3) years of the cancellation of its registration.
- (6) The above fees are without prejudice to the fees payable under the International Insurance Act and Regulations for registration as an international insurer, or under the Mutual Funds Act and Regulations for registration as an authorized fund.
 - (7) All cheques and bank drafts should be made payable to the "International Financial Services Commission".
